Pedestrian Obstruction at N. Pollard and Lee Highway

Once again, County has installed a utility pole that blocks a sidewalk. But thanks to Gillian Burgess immediately alerting us, the CCA contacted County and arranged a meeting Christmas Eve morning with deputy director of DES Bo Bloomer. The problem is the new pedestrian walk light recently installed on the south west side of Pollard St by Lee Hwy, a few feet from the CVFD. Mr. Bloomer admitted the contractor had installed the pole about a foot too close to the curb. He explained that the contractor had discovered a water line under the sidewalk and made some adjustments on the spot, moving the pole to the middle of the sidewalk so he could install a 3 ft deep concrete piling. The lack of common sense in this solution however, is rather stunning. Now a safety feature has made a sidewalk less safe, at tax paver expense.

Joining us on this chilly morning was Ann Beckman, chair of the 5-points intersection committee. Tom Korn with the NC Committee and Chief Scott Pardi of the CVFD. continued on page 6

January CCA General Meeting Agenda: Community Services

In reviewing our 2013 survey results, we have strong minority interests in learning about retirement services, aging in place, foster care, and adoption and play groups. So this January for our CCA meeting we will host representatives of these services.

We have a wave of soon-to-be seniors. Cherrydale is fairly stable, with 43 percent here more than 15 years. When asked how much longer respondents planned to live in Cherrydale, 43 % said 10 or more years longer and another 25 percent indicated they would stay until "they take me out feet first."

Basically, 39% are planning to stay here in retirement and another 31% are unsure. We asked only those who do not plan to retire here why. 29% had reasons other than listed, 27% just wanted to move elsewhere, 20% said it was not be affordable to stay, 13% still hoped to live here, and 10% would move to be near other family. Only one respondent answered, "Not enough services for seniors to keep me in my home." However, seniors needing services probably did not fill out the survey.

She says 3800 Lofts is a great location and she has no regrets. She enjoys Cherrydale for its neighbor-focused feel. Parking is 'a pain', but she's encouraged by County's posture on finishing out plans to provide for that. She's also looking forward to the Capital Bikeshare station that's coming to the Safeway parking lot. "A lot of our customers are health-conscious, or otherwise adventurers, so it should be an even greater way to help folks find their zen with us," she says.

House of Steep loves local! In addition to their monthly open-mic night, they rotate local artists every quarter, support 3 local bakers, and sell relaxation products made by artisans who live in Arlington. They also have a retail shelf dedicated to local talent who want to sell their own goods at the store. Stop by for some tea and a foot soak. "Neighbors in the immediate community get 10% off just for all the support you've shown us in our first year," she says.

After reading a string about Thai 24 on the Maywood listserv, I realized that I'd never dined there myself. Just before Christmas, I made a point of having lunch there and thoroughly enjoyed it.

I reached out to Thai 24's manager, Kevin Borland, to learn more about the restaurant and its owner, Pimkan "Pam" Jutranggur. He explained that Pam grew up in Bangkok, but she spent three months every year on her grandmother's farm where she learned traditional Thai cooking. Pam's mother was also a chef and she owned a restaurant on the campus of Ramkhamhaeng University in Bangkok. Pam first learned the restaurant business by working with her mother in Bangkok and when she came to the United States in 1979, she began working at local Thai restaurants. She moved to Arlington a few years later. Pam purchased "Gap Thai" in May of 2012 and renamed it "Thai 24." Since then, she has made a number of improvements, including brightening the décor, obtaining a license to sell beer and wine, and most notably, changing the style of cooking and menu items to authentic Thai home-style.

Pam and Kevin especially enjoy this part of Arlington because it is safe, there is a great sense of community, and the neighborhood has a nice balance of quiet suburban living along with the conveniences of city life. As soon as Pam learned this restaurant was up for sale, she was excited to take over the business.

They want to get the word out to the community that the menu has substantially changed since the prior owners. The food here is now authentic Thai style. They use real fresh tamarinds to make their Pad-Thai sauce. Pam makes the curries with 100% Thai coconut milk. The tom-yum does not have the clear flavorless broth you find at most Thai restaurants. They can adjust the spiciness (heat) on nearly any menu item to suit your tastes. The restaurant is also vegetarian and vegan friendly.

Churches of Cherrydale (Pt 4): Saint Agnes Catholic Church

My wife Teri and I were both raised Roman Catholic, so it was an evocative moment at the 7:30 Mass we recently attended when the priest, wearing a stole and purple satin over white vestments entered down the

center aisle preceded by altar boys in black cassocks and white surplices carrying a crucifix. It took us back.

There are two daily Masses at St Agnes Monday through Saturday and four on Sunday morning (7:30, 9:00. 10:30, and noon) Parishioners genuflected and made the sign of the cross with a light, right-handed brushing of their upper torso before entering their pew. A nun in traditional black habit tended to the lighting of candles and called the congregation to the service. We sang hymns, recited call-and-response prayers, and listened to a sermon that quoted Nathaniel Hawthorne on "doubt." Practically everyone took communion. After the middle two Sunday services, attendees are invited to a coffee and donuts gathering.

A couple sitting near us identified the priest leading the service as the pastor of the parish, Fr. Lee Roos, saying, "That man has certainly found his niche in



life. He's so good at this job and he clearly loves it!" St Agnes's campus is the largest of all the churches of Cherrydale, comprising a pre-kindergarten through 8th grade school with 440 students, a currently unoccupied convent, a rectory with four priests in residence, a large Parish Center, and a spacious church that's both modern and traditional. The 7 banks of pews fan out in the semi-circular sanctuary under a high, wood-beamed ceiling, complimented by old-fashioned stained glass windows. The Parish Center houses a hall where Cherrydalers have voted and given blood for many years.

St. Charles Borromeo Church in Clarendon originally founded St Agnes as a Mission, at 21st & Randolph. It grew into a full-fledged parish almost 80 years ago. The multi-generational congregation is now 2000 families (about 5000 members), many of won have attended services for 40-50 years.

Of the church's many social outreach activities (including Boy Scout and Girl Scout troops), Fr. Roos is particularly proud of Brother Dennis & Associates. This program, named after a whimsical, fictional character, uses a portion of the proceeds from the weekly church collection to aid in disaster relief both locally and throughout the world. A major activity of late has been in concert with Madison County, bringing food and aid to the poor of that rural part of Virginia.

Each spoke passionately of the importance of a wide unobstructed sidewalk on Lee Hwy. Apparently a pole used to stand on this corner but was hit several times and taken down decades ago.

Thankfully, this time DES immediately admitted the pole was not placed in the correct spot and promises to move it. Still, the CCA is pursuing an option to not to have any pole there. If the CVFD agreed, and if the Arlington Historic Preservation Committee allowed, the walk light could be placed attached to the Fire Station. One could even argue that a walk light is not needed. Pollard is the narrowest street connecting to Lee Hwy. It is obvious when to cross and when not to, and it is not a busy street compared to the other intersections. In addition, a walk light could give false confidence to the pedestrian. The fire station is so close to the highway that east-headed cars on Lee turning right



onto Pollard lack a good view of the crosswalk until literally upon it. Hence, a pedestrian crossing Pollard would be better off watching if a car is planning to turn into the intersection rather than assuming the walk light provides safety.

I will be meeting with Bo Bloomer again in early January. He has only been with County for 6 months, so I will bring him up to the present on the debacle that has been the decade long utility undergrounding on Lee in Cherrydale. In previous discussion with the County, the CCA emphasized certain important hard lessons and asked the County to incorporate a few new policies.

The first was to have DES actually show the CCA exactly where it plans to put utilities, specifically so we can avoid the oft-repeated excuse, "Oh it's too late, we spent all this money placing it here so now we can't change it". Second, we asked that DES inspect contractor work at the end of each day. This way clean up can be assured, damage assigned (e.g. when construction trucks gash highway trees), and mistakes caught promptly. We even volunteered Cherrydale residents to act as inspectors, if they just give us a heads up. If we know when work is being done we can send officers or neighbors out to examine the work. Third, we asked that jerry-rigging in the field corrections be vetted by a senior County representative and better yet, by the CCA.

While we understand engineers want to finish a days work quickly, we now have 2 very expensive examples of how on the spot extemporaneous corrections have been ruinous. The walk light is one example but the more notorious was the placement of 3 large utility boxes on the corner of the property by the I66 on-ramp. Here, once again, engineers found an underground water sewer, so they created a 3 foot hill over it and then placed the 3-5 foot utility boxes on top. This created an eye sore at the entrance to Cherrydale, a scary place to walk by (too easy for thieves and attackers to hide behind the units just a foot from the sidewalk). It also reduced the visibility of the down hill bike path as it connects to the walk way. And finally, it permanently blocked the CCA from planting shade trees there.

Our final recommendation had been to have engineers walk their projects while wheeling strollers and or using wheelchairs. Seriously, anyone trying either or both actions will have a more appreciative concept of the struggles and the needs of all pedestrians. Pollard is one block from the Cherrydale Health Rehabilitation Center. Many of their residents travel to the 7/11 and Safeway. They already hate the Pollard St intersection and prefer to cross at Oakland. Any so-called safety feature that narrows the walk further is a no-go for our disabled neighbors.

I am hopeful that with the new DES deputy director we have found a listener who will grow to love and protect our community. Any lessons learned here will help all other neighborhoods.

Officers know of 2 residents who moved away due to insufficient resources to keep them here.

35% of respondents said they are either now or in the future interested in Aging in Place services while another 20% said "maybe". There is a strong minority interest in "Aging In Place" services in the future here in Cherrydale. Of note, 27 people said they do not plan to retire in Cherrydale because it is not affordable, and 26 of these respondents were younger than 65. So let's try to address this now before it's too late.

A slight majority of us, 56%, have 1 or more children under age 21 living at home. By cross referencing, we found that of the 139 respondents who said they had kids under 21 living with them 46% had a stay home parent.

Only two households said they had or have foster children. But 25 respondents said they might be interested in fostering in the future (plus 4 definites) and another 35 stated they were unsure. That is a total of 64 families with at least potential interest in fostering children in need! This is significant untapped service opportunity. Our neighborhood could potentially resolve the shortage of foster homes for all of Arlington County.

Playgroups - 32% of families with kids would be interested in joining a local Cherrydale based playgroup. Of that group, most were for elementary school 53%, followed by toddler 47% and infant 28% and middle school 14%. All that is needed here is volunteers...

Gardener's Corner

The shortest day of the year in the northern hemisphere is December 21st, the winter solstice. From the advent of the solar calendar, cultures have been holding celebrations on this day in association with their religious beliefs. At this time of the year all of the season's agricultural work would have been finished and the days were dark and cold. People were indoors and free of the bulk of their chores. If you make your living as a landscaper like I do, then the agricultural ebb and flow of the seasons still largely applies. In reference to the suburban garden, the plants are in dormancy and the ground is frozen, so now is a good time to rest, relax and reflect.

While snow will have to be removed from paved surfaces like the driveway, walkways and streets, it can be left alone on planted surfaces. Plants with marginal cold hardiness should have been mulched and protected from frost before the onset of winter. Late winter is the best time of the year for dormant pruning but not until February or March. The year's gardening work is finished. Take some time off.

If you kept records of your garden, now is a good time to look them over and think about the next year. Walk the garden in winter and take note of the structure of trees and shrubs as they are bare of leaves. Pay attention to the garden beds and pathways. Their layout is easier to see without all the vegetative growth of the summer. But most importantly: take a load off. Read a book next to the fire. Go on vacation. Meet with family and friends. Drink, eat and be merry!

Lee Highway Utility Undergrounding

The County is in the final stages of completion for this phase of the project. Comcast has removed all of its overhead cables between N. Oakland St. and N. Quincy St. Dominion Virginia Power has completed the underground cable system and removed 5 poles along the south curb of Lee Hwy.

Arlington County Traffic Engineering and Operations has replaced the existing traffic signal at N. Pollard St. The new signal heads are supported by mast arm poles rather than by span cables that cross over the travel lanes on Lee Highway of the intersection. At the time of this report, the County started to remove the 5 poles and attached cables at this intersection that were part of the old signal. The 5 poles are on schedule to be removed by the end of December.

Upon completion of the work described above two Verizon poles located in front of the Brown Honda dealership have yet to be removed. The County is disappointed that Verizon has not completed their pole removals despite its repeated requests. The County has been in contact with Verizon and will continue to request the removal of the poles before the end of the calendar year or soon thereafter.

The County plans to start construction of the parking lane in front of the Bromptons in January 2014. The scope of this construction will be to remove the old concrete curb and sidewalk and place the base asphalt. The remainder of the streetscape project between N. Oakland St. and N. Quincy St. is scheduled for construction to start in the summer.

2013 CCA Treasurer's Report

This has been a deficit year, as we have had increased printing bills due to longer newsletter length. Advertising in Sweet and Sour News is the single largest revenue source. Ads, which typically pay for printing and more, have been slightly lower as ad sizes are smaller or repeat fewer times. Despite this, CCA has good cash reserves. Looking ahead, Officers have discussed keeping control on the newsletter length, by continuing longer pieces on the web site. 


